What is COA?

COA is Certificate of Approval or Permit issued by Energy Commission (ST) to manufacturer and importer for regulated electrical equipment which has been certified as complying with the specified standards, technical specification, technical checklist and/or technical declaration.

Types of COA

There are three (3) types of COA which are:-

- 1) COA for Manufacture
 - > New COA
 - > Renewal COA
- 2) COA for Import
 - > New COA
 - > Renewal COA
- 3) COA for Exhibition

Who can apply?

Only registered company in Malaysia which has been registered with Companies Commission of Malaysia (SSM) can apply.

How to apply COA?

- The applicant is required to apply COA through e-Permit <http://epermit.dagangnet.com>
- Details online registration shall refer to Dagang Net Technologies Sdn Bhd at free toll 1-300-133-133

What is COR?

COR is Certificate of Registration to Manufacture/Import issued by Energy Commission (ST) to manufacturer and importer prior to they apply for COA.

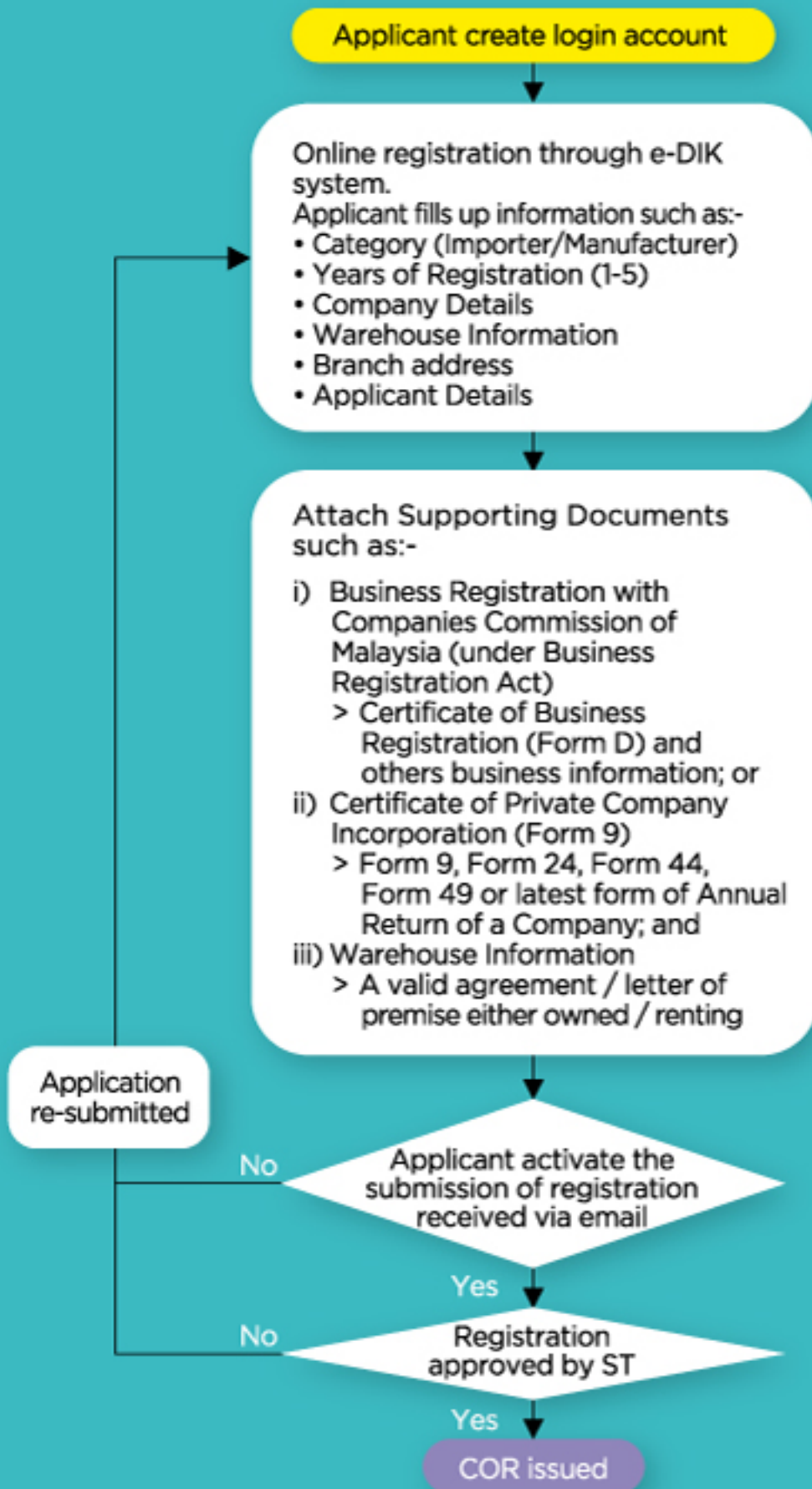

COA Validity

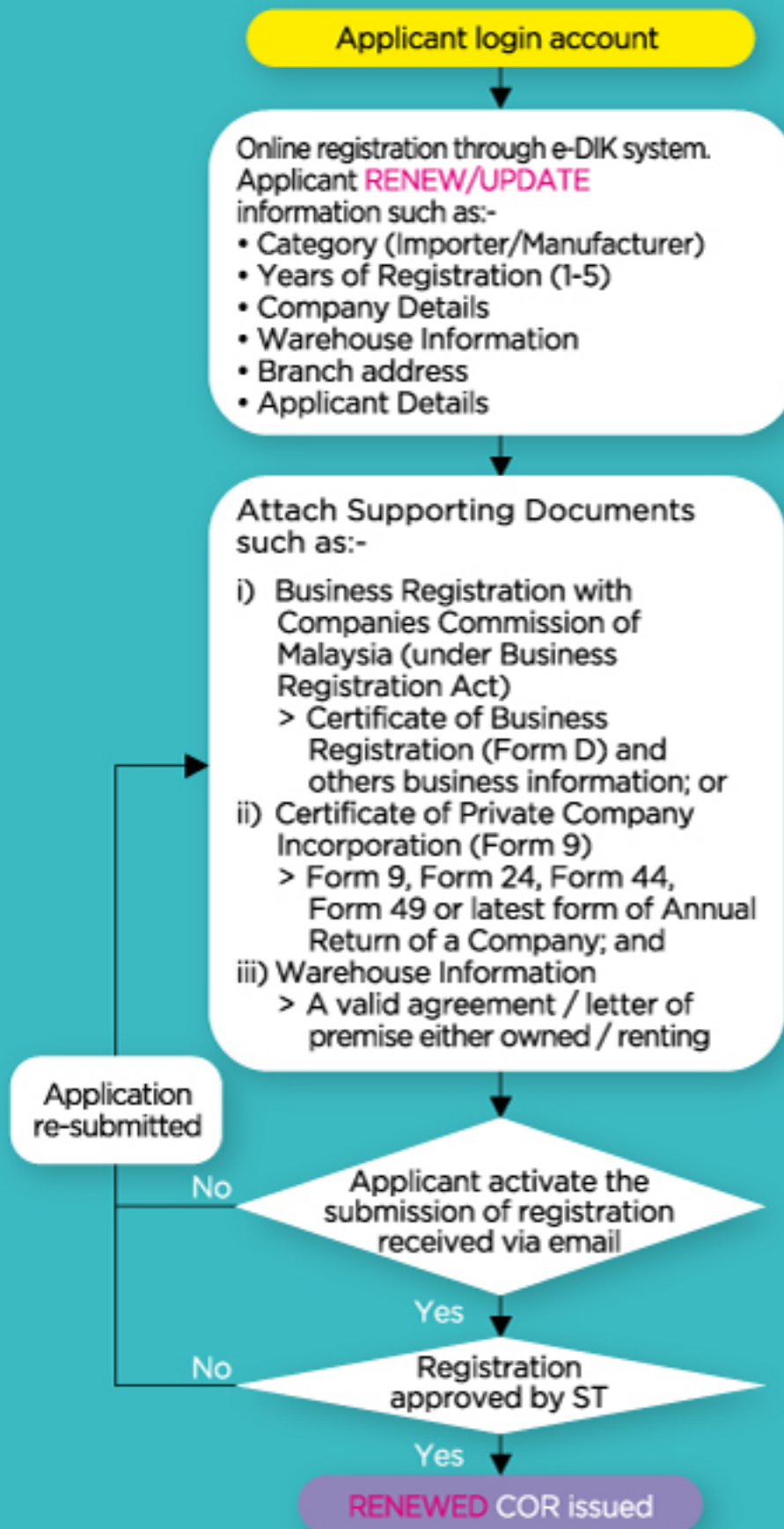
- New COA - 12 months
- Renewal COA - 12 months
- COA Exhibition - re-export or returned to country of origin after exhibition end

A. NEW Application for Certificate of Registration (COR)



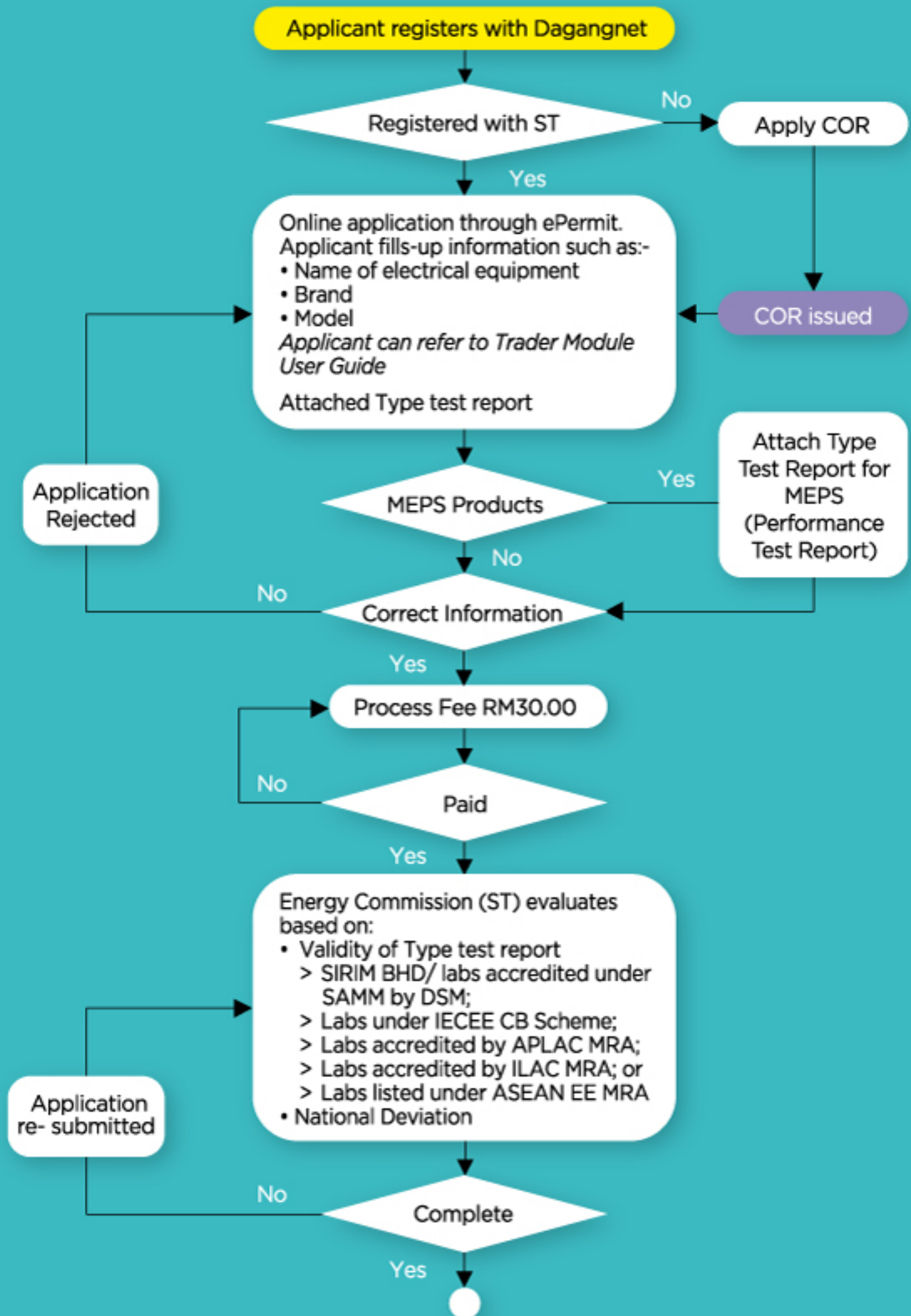
B. Application for **RENEWAL** of COR (Import/Manufacture)

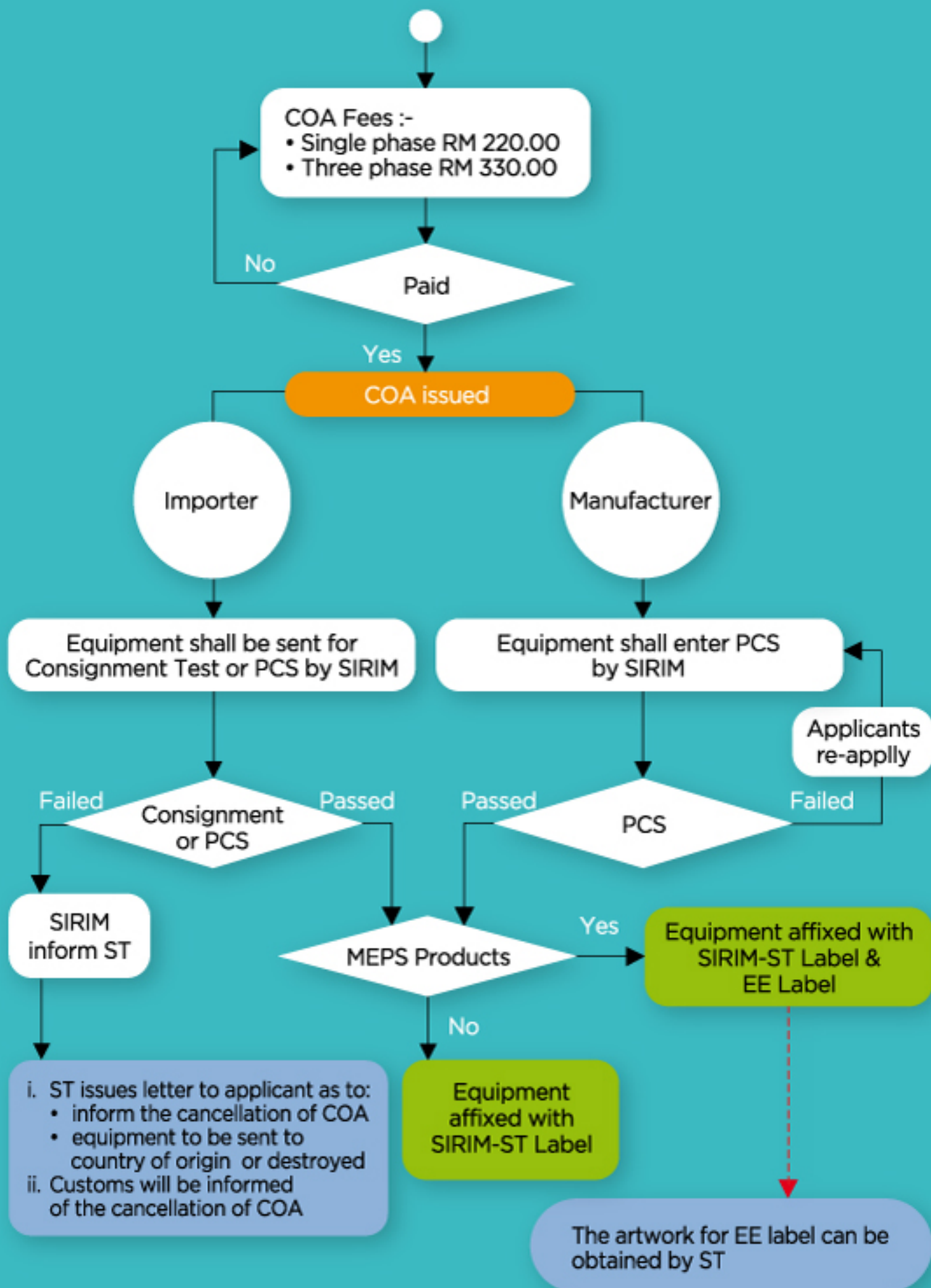


Notes:

1. Renewal of COR shall be made within two (2) months before the expiry date and not less than 14 days before the expiry date.
2. Application for Renewal of COR received less than 14 days before the expiry date will automatically be rejected. In this case applicant needs to apply for a new COR.

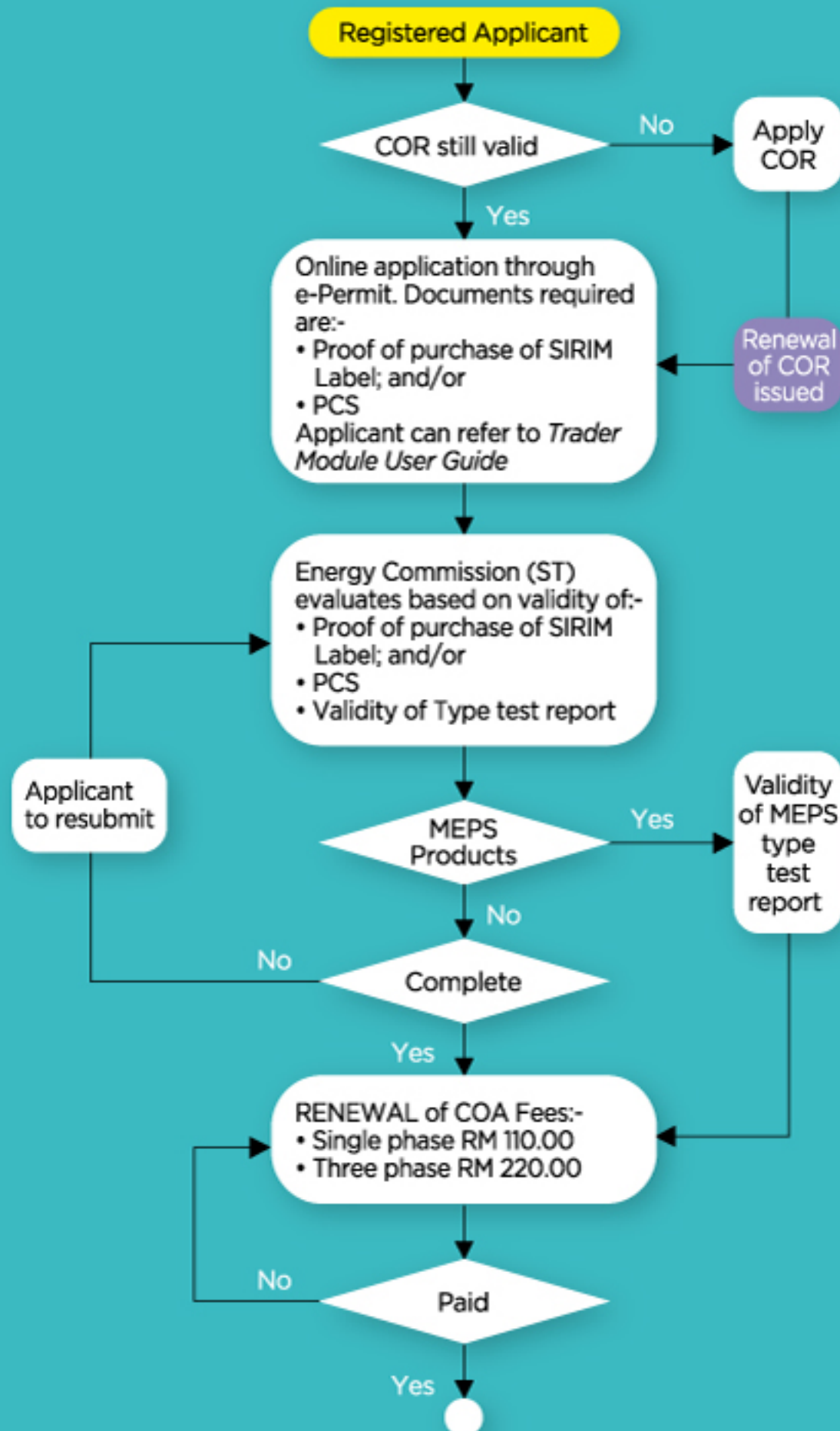
C. NEW Application to Manufacture / Importer (COA)

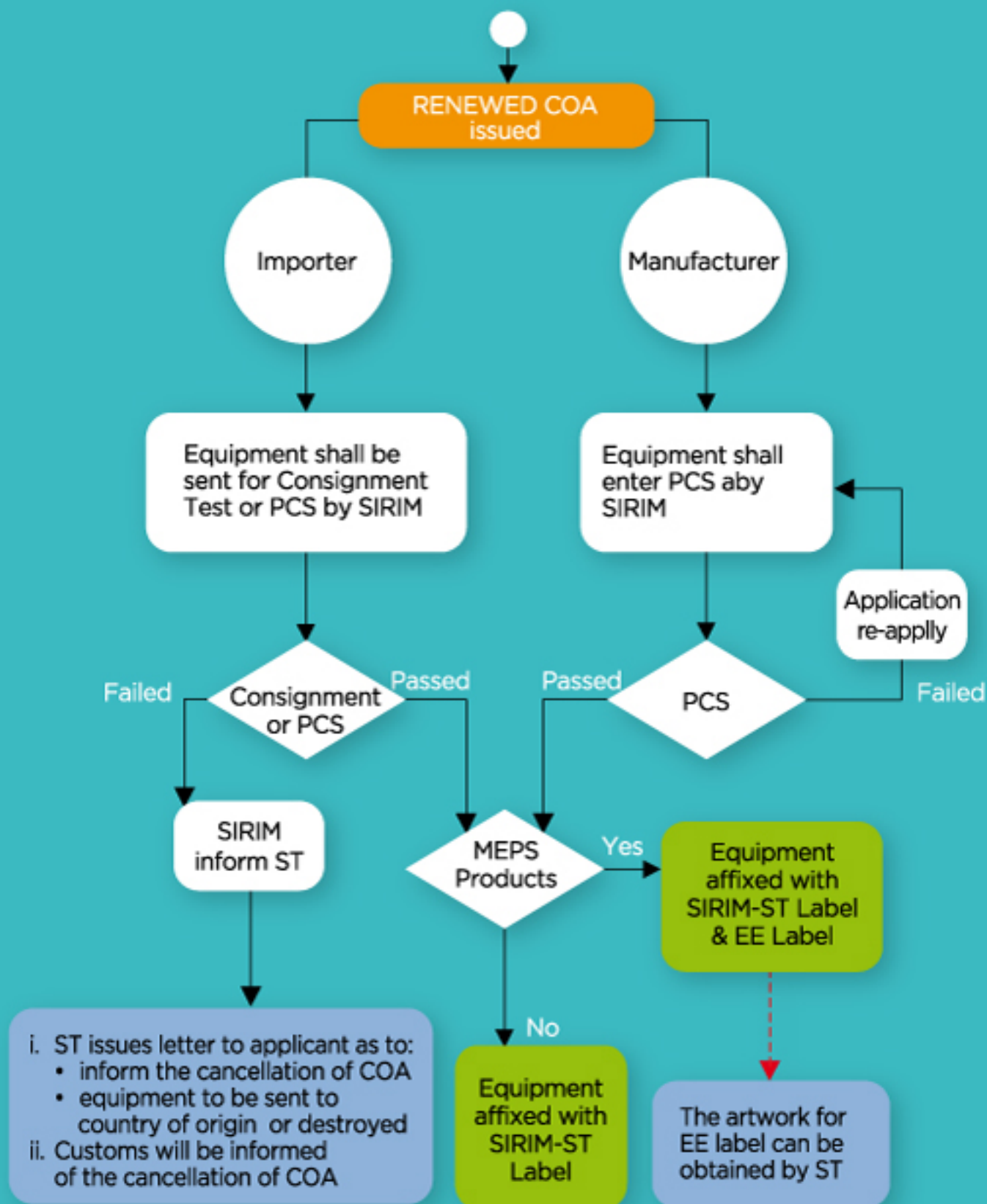




- * PCS = Product Certification Scheme

D. Application for RENEWAL of COA (Import/Manufacture)



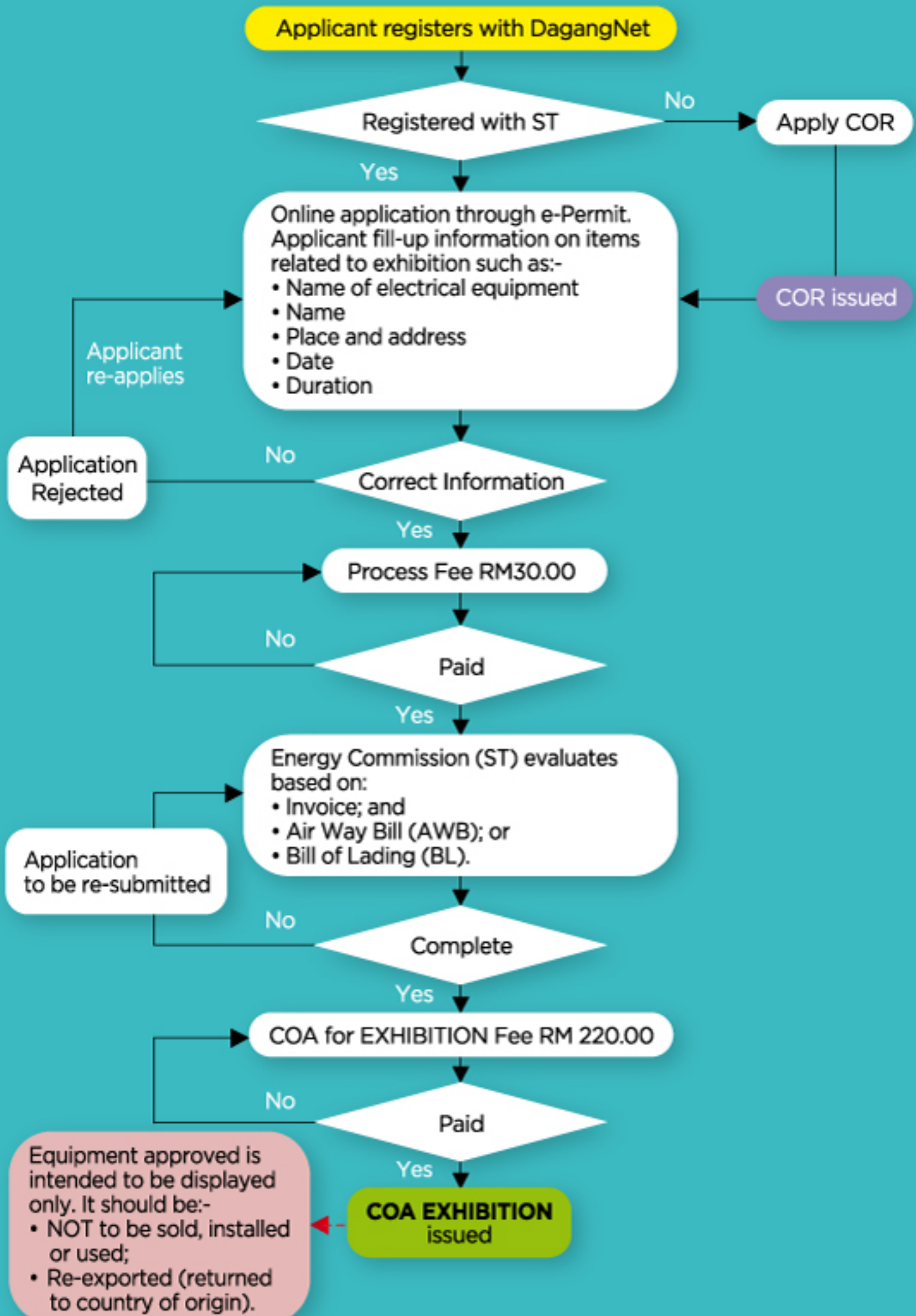


- PCS = Product Certification Scheme
